Please note if you request one meter for a single tract that is divided, you cannot request an additional meter at a later date. You will be considered requesting multiple meters and will have to begin the process again.

THE PRICE OF STANDARD SERVICE MAY BE CHANGED TO NON-STANDARD EVEN FOR ONE METER IF A ROAD BORE OR LINE EXTENSION IS NEEDED TO SERVICE TO BE PLACED ON YOUR PROPERTY.

IF YOU REQUEST ONE METER ON A PROPERTY AND LATER DECIDE TO ADD AN ADDITIOANL METER, YOU WILL HAVE TO SUBMIT ANOTHER METER REQUEST FOR THE 2ND METER. IF YOU DIVIDE THE PROPERTY INTO 2 OR MORE TRACTS IT IS NON- STANDARD.

PLEASE ALWAYS MAKE SURE WATER IS SUFFICIENT IN YOUR AREA. THERE IS NO GUARANTEE WATER IS AVAILBLE WITHOUT UPGRADES FOR NEW SERVICE, TERMINATED OR DISCONNECTED SERVICE.

YOU ARE SUBJECT TO DISCONNECTION WITHOUT NOTICE UNTIL THE SITUATION IS RESOLVED. WE HAVE CONTACTED SOME PROPERTY OWNERS AND WILL START CUSTOMER SERVICE INSPECTIONS SOON.
